Positive progress made across governance, youth development, and financial stability.

4. Confirmation of Board Members

The following Directors were confirmed by unanimous approval:

• Non-Executive Director (Finance, Governance & Strategy): Dale Simkiss

Decision: Board structure and rotating chair arrangement formally adopted.

Action: Companies House record to be updated if required and structure published on the club website.

5. Reports

Finance (Simon Barrand for Dale Simkiss): Presented financial overview for FY 2023/24 and FY 2024/25. Financial year-end now set to 1 July – 30 June. **Decision: Treasurer's Report approved and adopted.**

Football (Dan Horler): Reviewed senior and youth performance; emphasised player progression and discipline record. Focus for 2025/26: alignment between youth pathway and adult football.

Youth (Andy Major): Youth section continues to grow; 14 teams now active. Safeguarding compliance and coach education ongoing. Next step: increase parent volunteer involvement and maintain FA Charter Standards.

Commercial (Simon Barand): Sponsorship targets exceeded; new local partners onboarded. Planned fundraising calendar for 2025/26 to include community fun day and tournament expansion.

Welfare (Becci Thomas-Uden): Safeguarding audit completed. 25 DBS checks completed. 5 awaiting completion. Ongoing focus on mental wellbeing support for players. Use the welfare officer for the benefit of all.

6. Motions & Proposals

- a) **New Committee Structure** The 2025 Committee and Governance Structure (v2) reviewed and approved unanimously. **Decision: Adopted as the official club operating framework. Action: Publish on website and circulate to managers and volunteers.**
- b) **New Club Operating Rules** Revised Operating Rules (v5) tabled for adoption, incorporating updated financial year and membership definitions. **Decision: Approved unanimously. Action: Secretary to file updated version and issue to County FA.**

7. Q&A / Open Forum

Members raised questions regarding timelines for new clubhouse and a recent Discipline issue was discussed amongst the forum.

Social media – it was agreed that Youth and Adult facebook pages should be combined – one club!
